## *In the Park...*



### **Candleridge Park News**

1. **\*\*NEW PARK CURFEW HOURS: NOW 5 AM TO 9 PM\*\***—PACS has made the decision to standardize park hours to maintain consistency with all city parks. Since Candleridge Park is part of our neighborhood, we were granted an exception to the standardized hours. This will allow early morning and evening access to our working residents who exercise before or after their work day. The revised park closure time will help in providing a much safer and peaceful neighborhood. This decision was also supported by FWPD. The new park hours will be posted right above the new city ordinance signage.
2. Still no new update on the footbridge erosion project, so let's keep our fingers crossed that this will happen this year.
3. The fiber bar on the playground has been replenished. Additionally, after a safety inspection on the playground equipment, some repairs were made and completed.
4. The flag spotlight has just recently been replaced.
5. The PACS team is still doing other regular maintenance such as trash pick up, limb pick up, and making sure that debris is removed from the lake. The schedule for mowing, weeding, and major trimming will resume in the spring.
6. Coyotes are on the prowl again, so maintain safety precautions to keep your pets safe.
7. Stray and/or escapee dogs continue to be an issue around the park and neighborhood. Many fences in the neighborhood are not escape free and are in need of repair. A quick fix isn't always the best solution though it may seem cost effective. Dogs must be on a leash and supervised at all times. Also, tethering your pet to obstacles is also against the law.

We give much thanks to all who contribute in many ways to help maintain our beautiful park. Residents, keep up the good work by watching out and reporting suspicious activities in the neighborhood. Your consistency in doing so keeps our neighborhood a safe place to live.

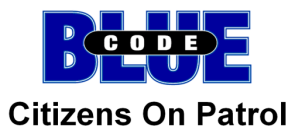
Thanks Ruben, we appreciate all the hard work you perform watching and monitoring our neighborhoods. You stay warm and safe.

**Property Issues:  
Streets and Houses**

Since early January, I have been trying to make contact with someone in the street department so that I could write an update on the street resurfacing going on in Candleridge. I have talked to Mr. Islam who was initially involved with the project but apparently now is not. Since January 15<sup>th</sup> he has been trying to get someone “in the know” in the street department to call me back. As of this writing, no one has called me back. Mr. Crabtree, a street superintendent for this part of Fort Worth, has not called me back.

Many of you, like myself, have several unanswered questions regarding the recent street repairs. It now appears that Cinnamon Hill, Saldana, and the cul-de-sac on the west end of Willow Way are to receive completely new asphalt as opposed to the seal coating most of us are getting. We want to know why those streets are getting pretty much completely redone while others are just getting the seal coat. While those streets were not in great shape, they were, in many people’s opinions, in better shape than some of the streets that are just getting the seal coat.

Residents want to know what the plans for Foxfire are, since nothing was shown to be done on that street and it’s in pretty bad shape. I did inform Mr. Islam that following that first hard freeze we had that the seal coating on Sparrow Point has developed several perpendicular cracks that run the full width of the street. There is also one on French Lake, and I suspect, other streets as well. He told me that the seal coat should not be cracking. So, what’s the solution? We’d like to know.

I have had several calls in the last month about more than one family living in one house. The official city rule of law is that there cannot be more than five unrelated people living in one house. If you suspect that this rule is not being followed, call our current code officer Brooke Stevenson at 682-802-5130. If you look at our deed restrictions, our homes are permitted for the “occupancy of a single family.” A homeowner who feels that his property is being “damaged” by several families living in one house nearby can also seek a civil remedy to this situation.

# Welcome New Neighbors

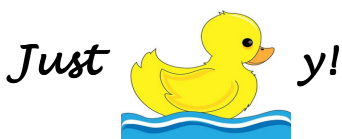

*Do you have new neighbors?*



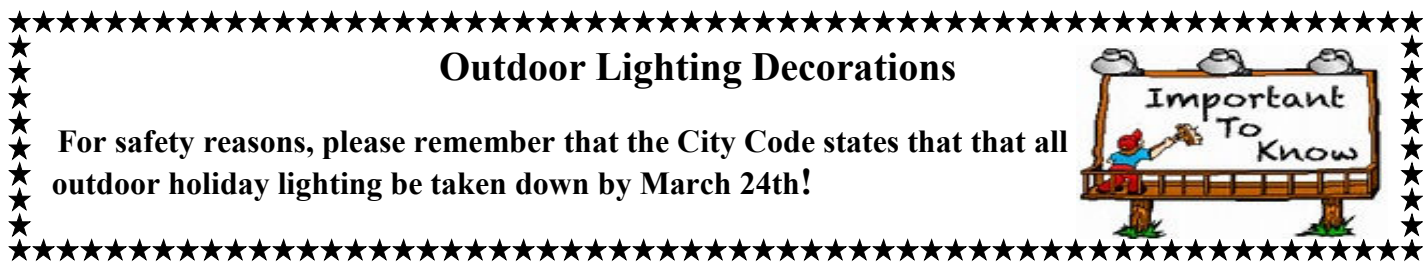
Oh what a joy it is to see our visiting migratory ducks as well as some occasional sea gulls. Our feathery migratory visitors consist of widgeons, shovelers, and scaups which will be visiting until the mid-March timeframe. Since the winter brings a bigger appetite to our feathery friends, supplemental food helps to provide the needed warmth they need during this time. Since ducks don't roam much during the colder months, remaining in the water and lakeside provides additional warmth and safety from hungry winter predators. We welcome six muscovy ducks that have surfaced at the lake and have made their home here. We lost all of this breed back in 2015 to poachers and to the virus outbreak. Recent frigid temperatures caused the lake to freeze over for a few days. Our feathery friends survived by swimming vigorously through the night in order to keep a small section of water on the north end of the lake moving so that they could remain in the water for added warmth. The lake's freeze brought out many visitors and some photographers to see and take pictures of the ducks and sea gulls flying in and landing on the ice. It was definitely a KODAK moment! It was even more exciting to see how many people came out all bundled in extra layers to bring additional food for the ducks during this freezing time. THANK YOU! THANK YOU!! We continue to be very thankful for all of our supporters who provide food or monetary contributions so that the supplemental food can be purchased.
