## *In the Park...*



The city is currently reviewing its chosen consultant's proposal for our upcoming erosion project at the lake and will begin the design of the proposed improvements in July. The proposed schedule has the construction beginning in May 2020.

Daytime patrolling by COP and FWPD has been in full force. Speeding cars have become a serious and dangerous problem in the neighborhood (30 mph) and especially around the park area and in the alley ways (20 mph). The mounted police recently visited the park and actually stopped speeding vehicles along French Lake Drive. As residents, we must set good examples by complying with the posted speed limits. Remember to stop for people, leashed pets, and ducks crossing the street. Proceed once they have safely crossed but be mindful that any person or animal could dart into the street from between cars at anytime. Being careful, respectful, and courteous prevents problems.

We appreciate that PACS (Parks and Community Services) and the City maintenance contractors have resumed the regular park maintenance schedule. Workers are busy mowing, weeding, collecting trash, removing fallen limbs, and keeping debris removed from the lake, especially debris after rain.

Our lake fountain has been removed for some needed warranty repair work and should be back soon.

Even though coyote sightings have not been reported in some time, always play it safe and be aware of their existence. Keep your pets out of harms way by supervising them and leashing them when they are outside of a fenced area.

Many need a refresher on animal code compliance laws since there have been an enormous amount of loose dogs in our park/neighborhood these days. We know how important your pets are, so make sure they stay safe and do not harm other people and other pets. Provide pets with an escape free yard and keep them on a leash while walking in the park or neighborhood. Make repairs to fences when needed and don't put pet safety at risk.

Remember that the park is not a drop off spot for children. Children should remain supervised by an adult at all times; otherwise, child abandonment laws will be enforced.

In order to keep our park a safe and beautiful place to visit, we must all contribute and comply. A special thanks to all who regularly maintain consistency in doing their part. ### Code Concerns

There are many issues that face our neighborhood. Our streets, street lights, and infrastructure are aging and often need reported to the City. We also have some crime that we need to be vigilant about reporting. We can all watch and report litter issues, people poaching ducks at the lake, suspicious vehicles or people, and code violations (standing water, high grass, abandoned vehicles, off-leashed pets, shed placement, and non-permitted construction in particular). We ask your help in reporting any of these issues to the city.



Have limbs or brush that need picking up or have not been picked up? Individual tree and shrub limbs up to 8 feet long and 4 inches in diameter can be stacked for weekly pickup as long as there is less than 10 cubic yards of limbs. You will be charged for amounts over 10 cubic yards. Brush needs to be stacked and can be no more than 8 feet long, 6 feet high, and 6 feet wide.

Please remember that standing water breeds mosquitoes. If you know of areas that put Candleridge at risk, please call or text our code enforcement officer, **Bridgette Fleming** at 682-774-7287.

## Citizens On Patrol

### Thank You Citizens on Patrol Volunteers

We have a new Neighborhood Patrol Officer! His name is Brent Meredith. If you have any neighborhood concerns or just have a general police question, you can contact him at 817-992-0190.

The National Insurance Crime Bureau (NICB) strongly advises drivers to:

- Lock your vehicle, set the alarm, and take all keys or fobs.
- Take all openers with you. Do not leave a manual gate or garage door opener in a parked vehicle.
- Keep a picture of your registration on your cell phone. Do not leave the registration or other papers with personal information in the vehicle.
- Lock your vehicles. Never leave a vehicle unlocked and running to warm it up or while stopping for a quick cup of coffee. It only takes a moment for an opportunistic thief to jump in and drive off.
- Close your garage doors. Garage doors should never be left open whether your garage is located on the side or back of your home. Would-be thieves are constantly looking for items that they can resell.


