## *In the Park...*



There is no doubt that the park has been the "GO TO" place these past few months during the Coronavirus quarantine. Park visitors have been in great abundance, many of whom are new visitors. While visiting the park, the city has asked that citizens practice social distancing by keeping 6 feet away from those who are not in your household and that you refrain from using the drinking fountain and playground equipment. Our park hours remain 5 AM to 9 PM, even during summer months, and FWPD officers do patrol after hours to assure compliance of park hours. Remember too that smoking is prohibited in all city parks, that children must remain supervised at all times, and no motorized vehicles, including ATV's which are not allowed in the park and greenbelt areas or on public streets.

We have requested a revised update and the start date has been requested for the erosion project since the scheduled start date of early spring has passed.

During the summer, PACS (Parks and Community Services) and the city maintenance contractors are back in full swing mowing, weeding, collecting trash, removing fallen limbs, and keeping debris removed from the lake. We are especially thankful for their hard work and efforts during this time.

Currently there are no reports of coyote sightings, but be aware of their presence and protect your pets.

It has been confirmed that there are two beavers living at the park and surrounding lake area and which have already destroyed two trees. The city will be contracting with someone to have them trapped and removed from the lake. In the meantime, the city forestry division has installed wire caging around all of the smaller trees in order to keep the beavers from destroying them.

With the heat of summer upon us, we want to keep loose dogs to a minimum, so be sure to provide your pets with an escape free environment and keep them leashed while walking in the park or in the neighborhood. Repair fences if needed so that their safety will not be at risk. Also, we have had lots of poop in the park. Please remember to clean up after your pet. Bag dispensers are available should you forget to bring a bag.

Your continued contributions and compliance will help keep our park a safe and beautiful place to visit. We want to say "thank you" to those who are consistent in doing their part. # Citizens On Patrol

## Thank You Citizens on Patrol Volunteers

From a Citizen on Patrol point of view, we were grounded starting mid-March with no patrolling, no base operations, and no access to police stations. Even though patrolling in your own vehicle and basing from home would seem to employ all the safety rules of social distancing, it was felt that closing down completely was the most health-affordable way to go. As the city authorities started to ease up on our restrictions, COP activities were allowed to resume, again in the safest way possible. Traffic patrols started up in mid-April, and I hope that you have seen the cars with placards back on your streets. We all still base from the safety of our homes, and submit our reports via the internet. Access to our police substation on McCart is still not allowed.

Human nature being what it is, the bad guys have lots of time to find ways to get to you. Of course, since most of us are residence-bound more than normally, you have a much better chance of defeating home burglaries, but they ARE STILL OCCURRING! Even car burglaries are just as liable to continue. It is amazing how many of our neighbors use their garages as storage facilities and park in the driveway or on the street. This allows more availability for thieves to find accessible, UNLOCKED car doors, whether there are valuables or not, and the results of shopping in full view on the seats. Please continue to maintain your diligence and protect yourselves, your families, and your possessions.



Remember too that while you are driving that the speed limit on neighborhood streets is 30 mph and the park area and alley ways are 20 mph.

Something well beyond Citizen on Patrol jurisdiction is the increase in Scam activity. Whether over the phone or theft from your mailbox, there is a real upswing in the numbers of swindlers, liars, and even tricksters who want to get their hands on your needed support income. BE AWARE.

Last year, Wedgwood South had an area overrun with egrets. This year they have selected Candleridge for their home. The egrets are protected by law during their nesting season which will last until October. Residents of Francisco, Perry, Fuller, and Johnstone daily struggle the destruction and mess that the egrets have gifted them. The City of Fort Worth sends its street sweepers daily to these streets to help not only with the clean up but the smell that the droppings leave behind.

We have been facing a much harder year than we normally have to face, but let us continue to do so as a neighborhood, working together for the overall good.
