From the President's Desk...

Dear CandleRidge Homeowners and Residents,

It is almost time for our annual meeting! It will be on September 25th at Christ Lutheran Church on Sycamore School Road. Be sure and mark your calendars for this and see page 7 for more about it. We will elect new officers to the board and renew some that are still serving. We'll also be voting on updating the organization's bylaws. Councilwoman Mia Hall, NPO Officer Billy Atkins, and a Code Enforcement Officer will be there.

The egret situation was not a problem this year in CandleRidge, but behind Altamesa Church of Christ, there was a huge invasion. Since the City could not pull protected nests, the birds expanded their rookery. The birds pretty much made the homes unlivable because of all the bird feces. Keep an eye out next year as they can come back to CandleRidge if we are not diligent.

I attended the City of Fort Worth meeting at Southwest High School along with Midori Clark, City Affairs Board Member, to see the plans for the McCart Altamesa Corridor. The plan is to reconstruct McCart from I-20 to Crowley with every part consisting of at least 4 lanes of concrete pavement and new sidewalks. The project will start in either 2028 or 2029.


The City of Fort Worth also revealed the 2026 estimated budget and income forecast that night. The one-hour question and answer period with all the City department representatives is available to view at the City's website.

In the Park...



As summer draws to a close and September arrives, French Lake is as lively and beautiful as ever.

The big story this year at the park has been the ducks. Our permanent, year-round adult population has grown substantially. Several broods were hatched in the spring and early summer, and a surprisingly high number of ducklings made it to adulthood — more than half of them survived, far better than in past years. The reasons for this are easy to see: a high number of large broods, a temperate summer without drought, and, perhaps most importantly, a welcomed decline in predator attacks. With so many survivors, the lake has a thriving community of ducks that now seems sturdier and more settled than before.

But even more exciting, and unexpected, was what happened in July. One morning, visitors at the lake were astonished to find five Canadian geese gliding across the water. They were new to French Lake, but they seemed right at home, honking, dabbling, and mingling among the ducks. Since then, they've stayed with us, sometimes disappearing for a few days but always returning. We suspect they've been roosting at another nearby lake, perhaps Benbrook Lake, and that French Lake has become one of their regular stops.

The arrival of the new geese delights many visitors who pause to watch them with some amazement at their appearance this time of year. Their size, presence, and honking upon takeoff have added new character to the lake. Whether they settle permanently or just continue to visit now and then, they have helped make this summer at French Lake a memorable one.

Even better, these geese are coexisting well with Sarge. Because of the many ducklings this year, Sarge had to become a serial adoptive father: acting as the guardian and protector of a group of ten ducklings early in the spring, then switching to a new and smaller group when the first brood had reached adolescence, and now again swimming around the lake with yet another new flotilla of kid ducks. Every group marches to Sarge's commands: when to eat, when to rest on shore, when to return to the water, and when and where to bed down for the night. Sarge has fathered many, many ducks that he didn't really father.

As always, we're grateful for the interest and help of other neighbors who pitch in by supplying cracked corn and hen scratch, keeping our feathered residents well supplied with supplemental food.

We'll continue to watch, feed, and care for our feathered neighbors, and we hope you'll stop by soon to see the show for yourself.

CandleRidge Garden Club



Thank You Citizens on Patrol Volunteers

Citizens on Patrol was started in October of 1991 with only 105 volunteers. Today there are over 1,000 patrollers in Fort Worth. This all-volunteer unit was started in eleven neighborhoods and has expanded into nearly every sub-division and neighborhood in Fort Worth.

Citizens on Patrol's purpose is to project an image of security in each neighborhood by having patrols at various days of the week and at various times of the day in the volunteer's car or truck with Citizens on Patrol signs displayed on the vehicle. This presence lets a prospective criminal know that we are watching in this neighborhood and, hopefully, they will move on and leave the area. Members can patrol while walking or while riding bicycles or motorcycles. If a COP member sees a crime in progress, the member is to call it in to 911 or on a city provided 2-way radio which is monitored at all times by a base station operator. Our COP members do not ever personally confront a would-be suspect.



Ground rules do not allow COPs Patrollers to make contact with a prospective criminal, only to observe and call in the suspicious behavior observed. We are not allowed to put ourselves in harms way, and we are not allowed to carry firearms while patrolling. We are required to patrol a minimum of four hours per month, but patrollers can patrol as many hours as desired. Patrollers do get a \$25.00 reimbursement gift card for every 25 hours of patrolling to help off set their cost of gas.


I have been a Citizen Patroller for 6 years, and it is something that each of us needs to consider becoming. Currently, we only have 7 patrollers for CandleRidge. With crime everywhere all around us, we need more patrollers and for all of the residents to always be watchful and aware of suspicious activity and to not be inattentive to the crime wave that is currently striking all communities. The visibility of these COP vehicles with COP signs on them truly makes a criminal think twice. It is important for CandleRidge that we all project an image of readiness and security towards prospective criminals.

KNOW YOUR DEED RESTRICTIONS

If a house near you is up for sell or was just bought, especially by "flippers," please remind them of the deed restrictions. Just because something is "OK or within City Permit regulations" doesn't mean that it's OK in Candleridge.

Homeowners, please <u>read your deed restrictions</u> while you are in the planning stages and before building or adding to your home or property. This important document contains certain restrictions as to what can be added or modified to a property in CandleRidge. In short, the following is a brief <u>excerpt</u> from our Deed Restrictions and lists <u>some</u> of the main complaints that the Board receives.

- 1. No plot shall be used for any purpose except for the erection and maintenance of 1 private dwelling house designed for the occupancy of a single family. No plot shall be used in whole or in part for any purpose inconsistent with private dwelling house use. (no commercial operations)
- 2. All dwellings shall be constructed of stone, masonry, brick, stucco, or of a glass building material of the kind usually used for outside wall construction.
- 3. No fence, wall, or hedge shall be placed on any lot nearer to any front street than is permitted for the house on said lot, and no fence, wall, or hedge shall be placed on any portion of the site with a greater height than six feet (6'). No wire or woven fence is permitted on any part of any lot.
- 4. No animals, livestock, or poultry of any kind shall be raised, bred, or kept on any lot, except that dogs, cats, or other household pets may be kept provided that they are not kept, bred, or maintained for any commercial purpose.
- 5. No noxious or offensive trade or activity shall be carried on upon any lot or lots.
- 6. No sign shall be erected or maintained on any plot except a "for sale" sign or "for rent" sign, and it shall not exceed five (5) square feet in size.
- 7. Any portion of any lot that is exposed to the public view must be maintained by the property owner in a neat and orderly fashion. (Iron gates and fences are not privacy structures, and anything placed behind them must follow code rules.)
- 8. No outbuilding, shop, trailer, or residence of a temporary character shall be permitted.
- 9. No dwelling or structure shall be erected or maintained nearer than seven (7) feet from the side line of any plot and accessory structures encompassed by a 6 foot stockade fence.
- 10. No trailer, camper, boat, or other vehicle may be regularly parked, stored, or maintained in the front yard or side yard of any plot. (No parking in the grass is ever allowed.)

The CandleRidge Homeowners Association relies on each homeowner to "be a good neighbor" and abide by the deed restrictions. Remember, you signed an agreement (Deed of Trust) to abide by these covenants when you purchased your home.

As of this date, Dr. Hall plans to attend the CandleRidge Annual Meeting


